Based in Calgary, Alberta, Enerplus Corporation (Enerplus) prides itself on being a responsible North American energy producer with a portfolio of highquality oil and natural gas assets. Over the last few years, this initiative expanded to include capturing actionable data for the overall safety and social responsibility (S&SR) team. The system Enerplus selected for this was *VelocityEHS*. Tanzi Lee Kosten, SSR Project Manager for Enerplus, explains the transition.

"We knew we were ready to develop a central solution that would handle our safety reporting, our regulatory reporting, and help us meet our training needs," says Ms. Kosten. "We were also transitioning toward a greater focus on sustainability,

and we needed a system solution that would give us the data foundation."

According to Ms. Kosten, working with *VelocityEHS* went smoothly from the outset.

Enerplus used the incident modules to track its incidents, near misses and hazards, and soon added the audit and inspection tool for both internal and external audits and the training module. The rollout was easy and very successful. A key indicator of success was the instant buy-in from field operations employees, who represent the majority of the system's users.

"We were excited about having a central resource that could handle all of all of these data points," says Ms. Kosten. "Now, when we're experiencing incidents, we're happy to use the [VelocityEHS] tool for entering and managing data. It's easy for us. So both the rollout and the internal adoption were quite successful."

Ms. Kosten stresses that the solutions from *VelocityEHS* have allowed Enerplus employees to become more autonomous, as they can now get the information they need at a moment's notice.

"We made it so people can manage their own 'to do' actions," explains Ms. Kosten. "Enerplus uses the audit tool for observation in the field. The training tool allows workers to manage their courses when they have the time, and allows system administrators to go in and verify who has completed applicable required training. The dashboard has been received positively, because everyone can see everything in real time. It's no longer people asking people for details. Instead, our people can get what they need, anytime, with a few simple clicks. That's a win-win."

With the implementation of *VelocityEHS*, Enerplus has been able to deactivate other programs and procedures it had been using.
